### **II. Deadlines for 2011**

MMMSL Registration Procedures

1. March 9<sup>th</sup> - \$200 team deposit due (note: most teams elect to leave their deposit with the MMMSL Treasurer from 1 season to another)
2. Last week of March – Each team must submit their: (a) rosters, (b) player ID cards; (c) copies of driver's licenses; and (d) player fees (\$20 per player for MSA, and \$5 per player for MMMSL)
3. First week of April – Attach stickers to players ID cards; Verify that the DOB on the driver's license matches the DOB on the ID card and roster; Verify that the ID# on the ID card matches the ID# on the roster
4. April 15<sup>th</sup> – Each team must submit final payment for field fees and scheduling fees: Return player passes to teams
5. May 15<sup>th</sup> – Send electronic copies of all team rosters to MSA registrar

Total financial outlay for each team that is due to MMMSL:

\$20 per player (MSA fee)  
\$5 per player (MMMSL fee)  
\$5.25 per game (GLASRA fee)  
\$24.00 per (Field fee)

Total financial outlay each team that is due to referees on game day:  
\$60.00 per game (Referee fee)

Motion was passed to adopt the Over-40 division form of substitutions. Substitutions are allowed by both teams at any stoppage of the game or whenever the ball is out of play. This also allows players to substitute during corner kicks

### **VI. Practice field or Recreational League**

Josh Coty opened for discussion on the MMMSL to pay for a field for interested players to play.

### **VII. Schedule for 2011**

Schedule will remain the same for all leagues. Over 30 division may have a mid-season USA vs World game scheduled on rain date.

### **VIII. Revisit five-minute sit on yellow card**

Motion was passed by the over 30 division managers to remove Section 3.04 Rules of play section b) from the bylaws

#### Section 3.04 Rules of Play

b) In all divisions, the MMMSL recognizes and enforces a rule that any player receiving a yellow card (regardless of position on the field) shall leave the field of play and shall not return to play for at least 5 minutes. Referees should be informed of this before commencement of play and should be urged to allow these substitutions to occur. If a player refuses to leave the field of play, during the game, for at least 5 minutes immediately after receiving a caution (yellow card) the player shall be suspended for 1 game in addition to any other suspensions due to cumulative cards. The incident must be written on the game report or later verified by the league VP after talking to the referee.
